What we are offering (Offer)	<p>We are offering you the following discounts when you purchase a PowerOptimal Elon 100 Solar Geyser Conversion kit (Elon 100) on the LookSee platform (LookSee):</p> <ul style="list-style-type: none"> • 5% if you purchase the Elon 100 only; or • 15% if you purchase the Elon 100 and a residential solar system (solar system) on LookSee to the value of R100 000 or more (including VAT). <p>The discount will apply to the purchase and installation costs of the Elon 100 only. Installation of the Elon 100 and the solar system is limited to Gauteng and KwaZulu Natal.</p>
